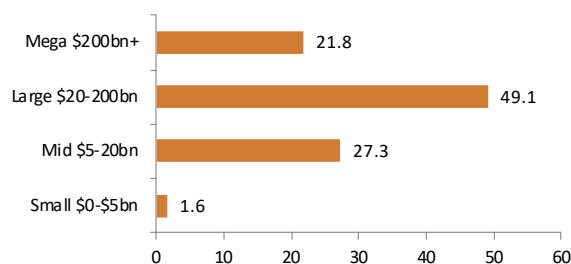

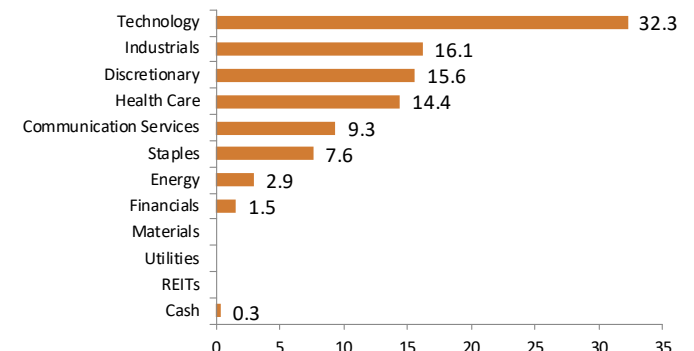
### Market Cap Breakdown
